Fully completed tender documents clearly marked **Tender No. 8/3/1-5/2024: "EMZINONI BULK WATER SUPPLY IN EMZINONI"** must be placed in a sealed envelope and placed in the tender box provided by **Govan Mbeki Municipality at the Reception area of the main municipal building, Secunda CBD 2302 by no later than 12h00 on 19/02/2025**. The envelope must be endorsed with number, title and closing date as indicated above.

A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Govan Mbeki Local Municipality where 90 points will be allocated in respective of price and 10 points for a specific goal. Govan Mbeki Municipality Supply Chain Management Policy allocate 10 points in terms of specific goals as follows:

- **Race (HDI) (3)**
- **People with disability (2),**
- **Youth (2)**
- **Woman (2)**
- **Implementing reconstruction and development program (1).**



No awards will be made to a person:

- Who is not registered on the Central Supplier Database;*
- Who is in the service of the state;*
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or*
- Who is an advisor or consultant contracted with the municipality or municipal entity.*

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

Bidders that do not hear anything after three months from closing date of this tender must consider their bids as unsuccessful.
