Church Streets, Hopetown not later than time and date stipulated or be sent via courier/hand delivered to reach the Tender Box, Thembelihle Local Municipality, Hopetown, 8750 before the specified closing date and time. The envelopes must be endorsed clearly with the tender number, project title, tenderer's name and closing date and time of the tender as above.

The tender will be evaluated on the 80/20 Preference Points system as prescribed by the Preferential Procurement Regulations, 2022 issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act Number 5 of 2000 (PPPFA) using Method 4 as prescribed by the Standards for Uniformity as well as functionality.. The following specific goals will apply:

The following functionality criteria will apply:

Minimum score for quality

In order to be considered for a contract in terms of this bid, bidders must achieve the minimum score for quality as stated below. The description of the quality criteria and the maximum possible score for each is shown in the table below. The score achieved for quality (SO) will be the sum of the scores achieved for each individual criterion.

Description of quality criterion	Maximum possible score
Expertise of key personnel	20
Availability/allocation of resources	20
Quality Assurance Systems which ensure compliance with employer's stated requirement	20
Approach Proposed to attain the Employer's Stated Objectives (Including Training)	20
Track record of tenderer (sewer related projects)	20
Maximum possible score	100

The minimum score for quality is **70 points**. Tenderers that fail to achieve the minimum score for quality will be rejected.

The tender box will be emptied just after 1200hrs on the closing date as above, after which all bids will be opened in public. Late tenders or tenders submitted by e-mail or fax will under no circumstances be accepted.

The Municipality reserves the right to withdraw any invitation to tender and/or to readvertise or to reject any tender or to accept a part of it. The Municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

It is expected of all Bidders who are not yet registered on the Central Supplier Database to register without delay. The Municipality reserves the right not to award tenders to Bidders who are not registered on the Database.
